The purpose of this meeting was to agree the schedule and plans for the Parish Christmas services following the recent announcement clarifying the Tier 2 restrictions and regulations that will be in place from December 2nd.

Services for December 6th and 13th will be indoors with the normal timetable. Stephen presented his draft plan, which had been discussed with relevant church wardens, for agreement at the meeting for the main Christmas services. The principle is that all Carol services will be outdoors, weather permitting, allowing singing. In most cases an alternative indoor plan is also provided and a decision to move indoors will be taken a few days in advance subject to weather forecasts. Indoor services will need to be pre-booked, via church wardens.

The outdoor services will be a maximum of 45 minutes with 5 readings and 7 carols. There will be music (details to be confirmed) and recyclable single use order of service sheets. Individuals will be encouraged to bring chairs or they may be provided by the church for those who need to sit, otherwise expect to stand.

These details will be communicated via the Benefice web site, Stephen's regular weekly letters, village facebook pages and email lists. The communication of alternative wet weather plans will be communicated via the local village networks as few days in advance.
